The District Attorney respectfully requests that the Board of Supervisors adopt a resolution authorizing the District Attorney to apply for the continuation of the Drug Enforcement Grant offered by the Office of Criminal Justice Planning (OCJP). This grant has been in effect in Mariposa County for 6 years and has been very successful in combating the major to mid-level drug offenders. In this grant year (96/97), the three components of the project (Law Enforcement, Probation and Prosecution), will focus their attention on the growing population of street level offenders as well as school-aged offenders.

On May 10, 1995, the Board of Supervisors approved the 95/96 grant, (Resolution #95-204).
