Recommend Resolution authorizing Chairman to sign the Declaration of Intent not to Apply for Rural Health Services Program Funding for Fiscal Year 1994-1995. We have been recently informed that the County is no longer required to apply for funding in order for funds to be available from the State for the local hospital and physicians to benefit from available RHS funding (AB 816, Chapter 195 of the Statutes of 1994, Section 16935.5). By declaring intent "not to apply", the County will no longer be required to do a large volume of paperwork previously done by the Health Department to ensure that funds were available to the County, the Hospital, and Physicians for reimbursing indigent care.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board applied for RHS Funds August 9, 1994, Res. No. 94-327.
