1. Adopt the attached Resolution of Intention to reorganize the Little Bear Road Maintenance Zone of Benefit;
2. Set a date and time for a Public Hearing:
 - a. to consider the elimination of some of the additional types of extended services provided in the Zone of Benefit to be reorganized, and
 - b. to determine the appropriate charges for the extended services still to be provided.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The applicant has petitioned for the reorganization of the Little Bear Road Maintenance Zone of Benefit. This proposal has not been required as a condition of any Mariposa County permit. The applicant has petitioned for this Zone of Benefit reorganization, to suspend assessments against his parcel (APN -17-031-004), since the parcel's primary access road is not off Little Bear Road. This situation is the result of a re-split of one of the original parcels served by Little Bear Road. The re-split created three (3) parcels; two (2) of which are served off Little Bear Road, and the subject parcel of this discussion, which is served off Gann's Corral Road (not maintained by the Zone of Benefit).

**A RESOLUTION OF INTENTION TO REORGANIZE THE
LITTLE BEAR ROAD MAINTENANCE ZONE OF BENEFIT**

WHEREAS, PETER W. BRADBURY, as applicant and landowner of a parcel of property within the boundaries of the Little Bear Road Maintenance Zone of Benefit, Zone No. Z90-09, has made application for the reorganization of the Little Bear Road Maintenance Zone of Benefit, to suspend maintenance assessments against his parcel, and eliminate his parcel from the extended services provided by said Zone of Benefit, within Countywide County Service Area No. 1, in accordance with the provisions of Mariposa County Resolution No. 90-140 and California Government Code; and

WHEREAS, the zone of benefit affected is in an unincorporated area within the boundaries of the County of Mariposa; and

WHEREAS, the terms, conditions and reasons for this zone of benefit reorganization are expressed in an letter presented to the Public Works Department;

NOW, THEREFORE, BE IT RESOLVED by the Mariposa County Board of Supervisors, a political subdivision of the State of California, that the Board of Supervisors will hold a public hearing on April 4, 1995, at 11:00 A.M., in the Board of Supervisors Meeting Room, County Courthouse, Mariposa, California, to consider elimination of the additional types of extended services proposed in the zone of benefit to be reorganized, and a determination of the appropriate charges for the extended services that will still be provided.

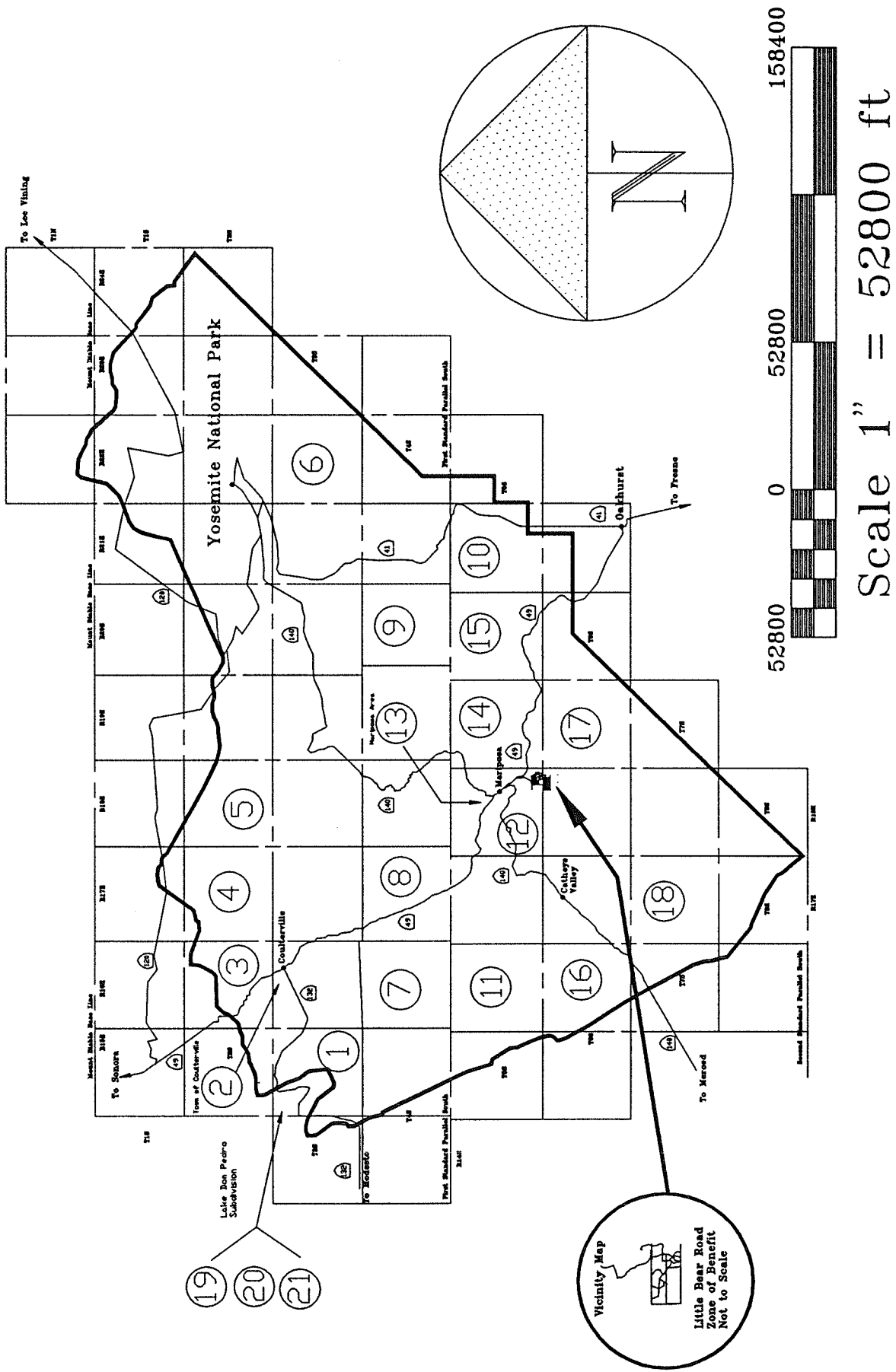

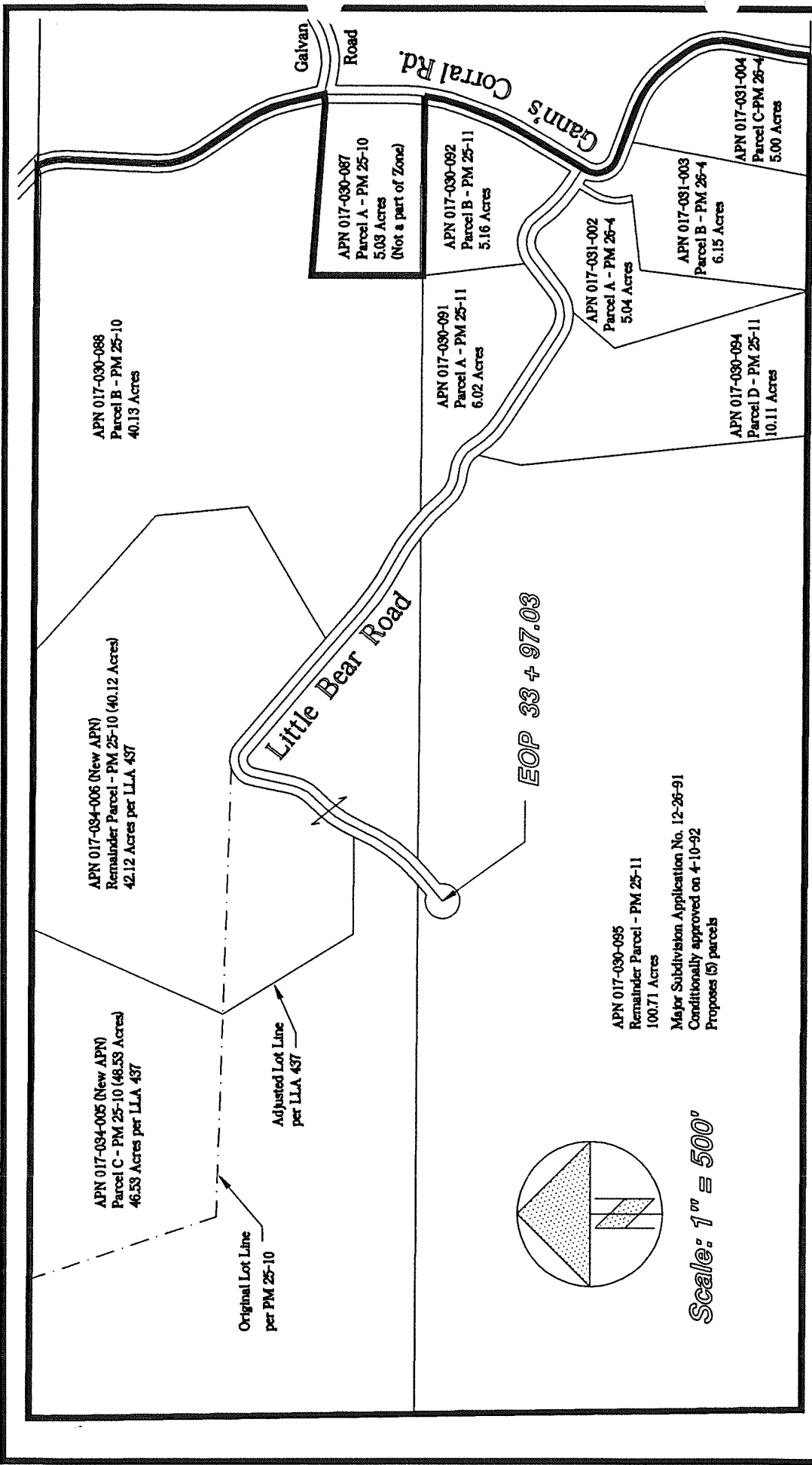
