RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes___ No X)

Public Works recommends that the Board reject the one bid received on February 17, 1995 totaling \$19,936.55 from Yosemite Falls Pump Service for the wet well replacement for Coulterville WWTP pump station #2, PW Project No 94-02. Public Works recommends that new plans and specifications be prepared for this project or that work be performed by County Forces. During preparation of the existing specifications, we were advised by manufacturers and contractors that installing a liner in the existing wet well would cost about \$10,000, and replacement of the wet well would cost about \$7,500. We therefore specified replacement. Two days prior to bid opening we received information about a liner material approved for use by the County Sanitation Districts of Los Angeles County which should be less costly to apply than material previously investigated. However, we received this information too late to issue an addendum to the bid documents.

Award or rejection of bids is required within 30 days of bid opening.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board approved plans and specifications for this project on January 17, 1995. Funding would be part of a \$25,000 Water Agency Grant for various upgrades at the wastewater treatment plant.

1. Award contract for bid amount of \$19,936.55 and increase budget by \$10,000.
2. Rebid the project as currently specified in hopes of obtaining a better bid.

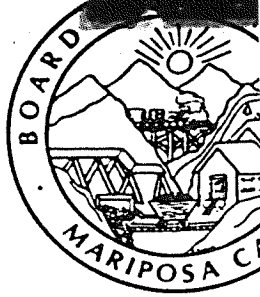
