Resolution In Support of AB138 (Goldsmith) Which Will Allow Local Governments to Set Their Own Spending Priorities and Authorize Local Governments to Calculate the Prevailing Wage for Projects When There is a Portion of Local Dollars Funding the Projects

BACKGROUND AND HISTORY OF BOARD ACTIONS:

This action supports the bill (AB138) introduced by Assemblyman Goldsmith. The bill is similar to AB193, which was supported by the Mariposa County Board of Supervisors in 1993 and which fell short of the votes needed to get out of committee. This action allows local governments to set their own spending priorities without the interference of the state and authorizes local governments to calculate the prevailing wage for projects funded by local dollars.

The bill is set to be heard in the Labor and Employment committee on April 19th and Assemblyman Goldsmith requests support. The bill is supported by Mariposa County Public Utility District Board of Directors. Copies of correspondence from Assemblyman Goldsmith and MPUD are attached for the Board's information.

In 1993 your council or board voted to support AB 193 (see attached letter) which would allow local governments to opt out of the state's costly prevailing wage schedule if the projects built were funded by local tax dollars.

Although the bill fell short of the votes needed to get out of committee, your support was crucial in shining the light on this burdensome mandate.

This session, I have introduced a similar bill, AB 138, which will allow local governments to set their own spending priorities without Sacramento's interference. The bill would further authorize the local governments to calculate the prevailing wage for projects when there is a portion of local dollars funding the projects.

I would appreciate it if you could put this issue up for a vote by your council or board. If the vote is in the affirmative, a letter of support would be helpful. The bill will be heard in the Labor and Employment committee on April 19th. Your prompt attention to this matter would be appreciated. 
