ACTION AND VOTE:

Mark Goodin, President of the Mariposa Educational 9:40 a.m. Tutor Resource (METR);

Resolution Authorizing Request from METR to Offer County Employees the Option of Having Donations to METR Automatically Deducted from their Monthly Paychecks

BOARD ACTION: Discussion was held with Mark Goodin concerning request; costs to the County for processing the payroll deductions; and consideration of establishing a policy for payroll deductions; i.e., restricting requests to 501c3 status organizations. (M)Balmain, (S)Stewart, Res. 95-168 adopted approving METR's request. Following further discussion, motion was amended agreeable with maker and second, directing that a policy be established for payroll deductions; and that approval of METR's request is conditioned that it be renewed on an annual Direction was given for the Auditor to come back with recommendations relative to types of organizations that should be allowed to request payroll deductions and to discuss costs of the program so that the Board can establish a policy. Unanimous.

Dear Board of Supervisors,

The board of directors of Mariposa Educational Tutor Resource, or METR, kicked off their first fundraising drive at the METR board meeting two weeks ago.

As President of METR, I am asking the County to make available to each county employee the opportunity to have one or two dollars automatically deducted from their monthly paychecks and sent to METR as a donation.

I have discussed this matter with the Auditor and he has no problem with the idea, (see attached letter). The local United Way already has such a mechanism in place, and it has been working well.

METR's plan is this: During non-county time, our board members will ask each of their "county" friends to have one dollar a month automatically withdrawn from their paycheck and paid to METR. We plan to ask administrators for a two dollar donation a month. With this almost painless approach, we feel that approximately 40 county employees and administrators would participate if given the opportunity.


