WHEREAS, CLEO served the community as teacher, Vice-Principal and Superintendent of Schools for nearly forty (40) years; and


WHEREAS, CLEO was a founder and President of the John C. Fremont Hospital Foundation; and





**WHEREAS**, **PAT** has been involved in senior affairs for fifteen (15) years and served as a member of the of the Mariposa County Commission on Aging; and


**WHEREAS**, **PAT** was a member and Vice-President of the Mariposa Senior Network; and


