A RESOLUTION EXTENDING THE AGREEMENT
FOR SMALL CLAIMS LEGAL ADVISORS

WHEREAS, pursuant to Resolution No. 82-18, the Board of Supervisors of Mariposa County entered into an Agreement with members of the Mariposa County Bar Association, at their option, to provide the individual advisory assistance services required by Code of Civil Procedures § 117.18 to small claims court litigants and potential litigants, and


WHEREAS, each fiscal year, the Agreement is renewed to identify the current bar members willing to serve in the capacity of *Small Claims Legal Advisors*;

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of Mariposa County, a political subdivision of the State of California, that the attached "NOTICE OF ACCEPTANCE" shall extend the current Agreement through the 1995/1996 fiscal year.

BE IT FURTHER RESOLVED that the Auditor shall pay said Bar members participating in this program on a bi-annual basis, upon the submission of an invoice by each participant to the Justice Court, with the first payment during the regular billing period in December 1995, and the final payment during the regular billing period in June 1996.




