RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes__ No X)

Resolution authorizing expenditure of up to \$1,200 from Public Works Admin budget, Improvement Projects line, for survey and roadway delineation for purposes of parking enforcement along Fish Camp Lane in Fish Camp.

The Sheriff's Office has stated that enforcement of "No Parking" areas along Fish Camp Lane, the entrance road to Yosemite Alpine Village subdivision (see map), cannot be accomplished unless the roadway is clearly delineated in the area near Highway 41. This area consists of a wide expanse of paving associated with the highway and the neighboring businesses through which Fish Camp Lane is not well defined. Uncontrolled parking during snow conditions has made the area unsafe and, on occasion, has restricted access for residents. The costs include surveying to clearly locate the roadway right-of-way (\$800 maximum) and striping of the edges of the travelled way (\$400 maximum).

One identified source of available funding is the from Public Works Admin budget, Improvement Projects line item. Currently, policy allows expenditure of these funds without further Board action if: 1) the project is in the public interest, 2) the CAO and Public Works Director agree on the necessity and expense, and 3) the project is on County property. This request meets the first two criteria, but not the third since the roadway is not owned by the County. It is a public access road, however, but is privately owned. It is maintained by the Alpine Springs Community Service District, an independent special district.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

On October 17, 1995, the Board discussed this issue, along with several other similar problems with winter parking control in Fish Camp. Supervisor Taber was directed to work with the various agencies involved toward a solution. This action represents one such solution.

LIST ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

1. No action. No enforcement of parking restrictions can reportedly be accomplished in this location.
2. Pay for these costs from another source of funds such as Reserve for Contingencies (4/5ths vote required).
3. Request that the Alpine Springs Community Service District pay for this work since the roadway maintenance is that district's responsibility.
