MARIPOSA COUNTY RESOLUTION NUMBER 95-523
A RESOLUTION RECOGNIZING GLENN E. SAVAGE
UPON HIS RETIREMENT FROM THE
CALIFORNIA HIGHWAY PATROL

WHEREAS, GLENN E. SAVAGE, began his State service with the California Highway Patrol on January 1, 1967, as a cadet at the California Highway Patrol academy in Sacramento; and upon graduation from the academy, GLENN reported to Redwood City as his first duty station on April 27, 1967, and served that community until transferring to the Madera Area on May 23, 1969; and on August 2, 1983, GLENN transferred to the Mariposa Area, a familiar area to GLENN, a place he went to school, a place he called home; and

WHEREAS, upon GLENN'S retirement from the California Highway Patrol on December 31, 1995, his fidelity to the Mariposa Area, good humor and likable personality will be missed greatly.

WHEREAS, GLENN was given the distinct honor of being the Area's "Drug Recognition Expert", which helped stem the flow of illegal substances into our county; and GLENN was held in the highest esteem by his fellow workers who looked to him for guidance, honored him for his knowledge and remained close to him for his innovation; and

WHEREAS, GLENN, being an avid hunter bagged his limit of deer with his patrol vehicle more than with his rifle; and

WHEREAS, GLENN, who patrolled the County of Mariposa for 12 years has an impeccable driving record; however, the case of the bent gate has yet to be solved; and when GLENN was given the Area's new Mustang to drive and officers asked why, he said "Because I'm a better officer than the rest of you" and GLENN proceeded to back out of the carport and into a metal building crushing it; and


WHEREAS, GLENN represented himself to others as the pinnacle of good health by passing the Department's rigorous physical fitness test annually through proper nutrition and exercise; and




WHEREAS, GLENN always fulfilled his obligation to his family, community and Department; and conducted his life and career in a manner that has set a good example for those who follow.


