The above-referenced ambulance is in the process of being registered in the County's name. Previously, Riggs was shown as the registered owner and Mariposa County as the lien holder. Riggs has signed over the vehicle to the County as the registered owner. Two items still need to be resolved prior to finalizing the transfer. The vehicle must be smog certified and have a tax clearance.

Fleet Maintenance has inspected the vehicle and is doing a tuneup and general maintenance to prepare it for the smog inspection. Once this is accomplished, the vehicle will be available to be put back into service. I understand that the Sheriff's Department would like to have it for a search and rescue mobile command center. This vehicle should be able to serve this function quite well.
