A RESOLUTION RECOGNIZING MARIE ESCOLA FOR HER
SERVICE AND ACCOMPLISHMENTS SURROUNDING THE
WAWONA/MARIPOSA COUNTY COMMUNITY

WHEREAS, Wawona has been a part of MARIE ESCOLA'S life for over forty-eight (48) years; and

WHEREAS, shortly after moving to Wawona in 1975, MARIE ESCOLA became a member of the Wawona Area Property Owners Association (W.A.P.O.A.), and has actively maintained a current membership; and

WHEREAS, in 1977, the Wawona Area Property Owners Association (W.A.P.O.A.) Board asked MARIE to assume the position of Board President, in which she has carried out her duties as President from 1977 through 1986, as well as from 1990 through June of 1994; and

WHEREAS, in 1977, MARIE worked closely with Yosemite National Park officials and Mariposa County staff in developing the Yosemite/Wawona Land Use Plan, which ultimately removed a building moratorium in the Wawona property area; and


WHEREAS, MARIE supported a Mariposa County resolution for the development of a Wawona Specific Plan, resulting in the establishment of the Wawona Town Planning Advisory Committee. MARIE has been an effective member of the Wawona Town Planning Advisory Committee since December 1, 1981; and




FORMALLY PASSED AND ADOPTED by the Mariposa County Board of Supervisors on June 14, 1994, by unanimous vote.
