RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes___ No x)

Public Works recommends a resolution awarding Public Works bid, PW 93-13 for one (1) Automatic Cabinet Parts Washer to Steam Cleaners, Inc. of Fresno in the amount of \$7,656.05, including all options as outlined on bid specs. This piece of equipment will save a minimum of one hour per day, per man in cleaning parts. It will also reduce the amount of money currently being spend to haul away waste solvent by over \$2,200 per year. This also addresses one of our environmental issues.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

On September 15, 1993, during the budget hearings, the Board authorized the Public Works Director to determine highest priority of purchases for shop equipment to be funded from the Vehicle Replacement fund with costs to be charged back to both shops.
