Authorize Chairman to sign Agreement with the County of Stanislaus for Donald O. Cripe, Stanislaus County Agricultural Commissioner, to provide Agricultural Commissioner services and Sealer of Weights and Measures services to Mariposa County. The laws of California allow Mariposa County to contract with Stanislaus County for these services as Mariposa County has neither an Ag Commissioner nor a Sealer of Weights and Measures.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Donald Cripe has been providing Ag Commissioner services to Mariposa County since 1986 when Mr. Cripe was Madera County Ag Commissioner. In 1990, the Board executed an Agreement with Madera County for Mr. Cripe to provide both services to Mariposa County, i.e., Agricultural Commissioner and Sealer of Weights Mr. Cripe is now associated with Stanislaus County, therefore, it is necessary that a new Agreement be executed by all parties.
