The Road Division has utilized the services of the Madera County striping crew for approximately 28 years to stripe the County-maintained roads.



AGREEMENT FOR SERVICES

(Under Government Code 31000)

This Agreement, made and entered into this 23rd day of August 1994, by and between County of Mariposa, a political subdivision of the State of California, hereinafter referred to as "**COUNTY**," and the County of Madera, a political subdivision of the State of California, hereinafter referred to as "**PROVIDER**."

WITNESSETH

WHEREAS, pursuant to Section 31000 of the California Government Code, a County Board of Supervisors is authorized, on behalf of any department in the County, to contract with persons specially trained, experienced, expert and competent to perform special services; and,

WHEREAS, **COUNTY** Department of Public Works requires the annual services of **PROVIDER'S** Striping Machine and Work Crew to stripe various locations within **COUNTY**; and,

WHEREAS, **PROVIDER** has staff with special training, experience and equipment needed that are fully competent to perform the special services required by **COUNTY**.

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:


1. **PROVIDER** will assign a striping crew to County Department of Public Works for a period of approximately ten (10) working days. The assigned days shall be coordinated between Director of Public Works of **COUNTY** and County Road Commissioner of **PROVIDER**. When assigned, the striping crew will work under the direct supervision of **COUNTY** Director of Public Works or his assigned representative.
2. **PROVIDER** to stripe center line of various **COUNTY** roads.
3. **PROVIDER** to stripe fog line on designated **COUNTY** roads.
4. **PROVIDER** to supply needed materials for striping, i.e. paint and glass beads.
5. **COUNTY** shall pay **PROVIDER** for all materials used by **PROVIDER** in striping **COUNTY** roads.

6. **COUNTY** shall provide room and board for striping crew during the striping project.
7. **COUNTY** shall compensate **PROVIDER** at the approximate rate of \$115.50 per hour for services of a five-man striping crew, including travel time. **COUNTY** shall compensate **PROVIDER** for use of equipment at the approximate rate of \$64.68 per hour.
8. **PROVIDER** shall be paid upon submittal of verified actual claim for total composite employee hours worked and total composite equipment hours used and all materials supplied.
9. The total annual amount payable under this Agreement for striping shall not exceed \$50,000.00 without prior written approval of **COUNTY**.
10. The intent of this agreement is for the hourly rates and not-to-exceed total annual amount to be determined annually as needed between the Director of Public Works of **COUNTY** and the Road Commissioner of **PROVIDER**.
11. **COUNTY** shall provide all necessary work space, supplies, communication, secretarial services, and/or technical services as may be necessary for the striping crew to carry out duties as specified in this Agreement.
12. This Agreement becomes effective on the date stipulated on Page One of this Agreement and continues until terminated by either party. This Agreement may be terminated at any time without cause by either party by giving fifteen (15) calendar days advance written notice to terminate.


