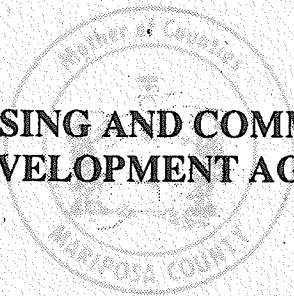

The Project is designed to investigate the feasibility of an American Indian Council-owned and operated business to provide traditional Indian crafts to Yosemite National Park. If feasible, the Project also includes the preparation of business funding applications to appropriate entities. Please see the attached Abstract for more information.
