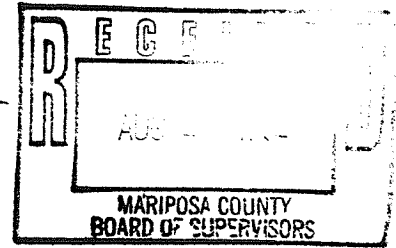

Per our conversation, the Lion's Club has expressed an interest in acquiring the above-mentioned vehicle for use in Mexico.

The County has no use for the vehicle since it will cost more than it is worth to make it road worthy.

A little background:

This vehicle was received from Riggs Ambulance in November, 1990, to be used as a Mariposa County Search and Rescue unit. Since that time, vehicle maintenance has spent more than 60 man-hours and several hundred dollars in parts to try to get the vehicle to run properly to pass the smog test. The vehicle was last worked on in June, 1993, after determining that it was going to need an engine rebuild before it would pass the smog test. We have determined it will cost between \$2,500 and \$3,500 to meet minimum safety and operational standards (depending on the extent of wear found).

Basically, it needs an engine rebuild, and possibly a transmission, in addition to various other problems noted in the attached letter to Rod Sinclair of June 18, 1993.

I have determined that the current wholesale value is approximately \$3,925. Our cost to make it road ready is around \$3,500, plus all the time already spent, leaving its' value at approximately \$425 net.

At this time, I feel the vehicle should be considered surplus and disposed of accordingly. This would be a good way of disposing of the vehicle since it would have to be completely stripped before it could be sold at auction.
