MARIPOSA COUNTY RESOLUTION NUMBER 94- 435

A RESOLUTION RECOGNIZING THE
JOHN C. FREMONT HOSPITAL DISTRICT FOR ITS
EFFORTS AND ACCOMPLISHMENTS and
DECLARING OCTOBER 16-22, 1994, AS
"JOHN C. FREMONT HOSPITAL DISTRICT WEEK"

WHEREAS, in 1947, a special election was held which formed the JOHN C. FREMONT HOSPITAL DISTRICT and the first Board of Hospital Directors was appointed by the Mariposa County Board of Supervisors; and

WHEREAS, on September 30, 1951, the completed JOHN C. FREMONT HOSPITAL was dedicated; and

WHEREAS, in 1964, recognizing the need for a long term care facility within the County of Mariposa, the skilled nursing facility, known as the Ewing Wing, was completed; and

WHEREAS, in 1979, the JOHN C. FREMONT HOSPITAL HOME AGENCY was formed; and


WHEREAS, in 1992, the JOHN C. FREMONT RURAL HEALTH CLINIC was established; and


WHEREAS, in keeping with its philosophy of providing the best medical services possible to the County of Mariposa, the JOHN C. FREMONT HOSPITAL DISTRICT has embarked on a project to improve the existing facilities by constructing a new clinic building and new quarters for Home Health/Hospice, Ancillary Departments and Support Services.


NOW THEREFORE, BE IT RESOLVED, by the Mariposa County Board of Supervisors, that the JOHN C. FREMONT HOSPITAL DISTRICT is hereby recognized for its efforts and accomplishments in the continuing improvement of medical services to the County of Mariposa.

BE IT FURTHER RESOLVED that October 16-22, 1994, is declared as "JOHN C. FREMONT HOSPITAL DISTRICT WEEK".
