Adoption of a Resolution approving the road name "Moss Creek Lane". The road name is consistent with the road naming requirements of County Resolution 92-541. The applicants state that the properties in the area have moss-covered rocks in the streams that run in the vicinity.

All of the property owners served by the road agree with the road name.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board adopted Resolution No. 92-541 in 1992 establishing criteria for naming non-County roads. Generally, road names shall be developed around some historical, botanical, zoological or geological significance as they directly relate to Mariposa County. First names of historically significant people shall not be used unless in conjunction with the last name. All property owners served by the road must be notified and a majority must approve of the road name request.

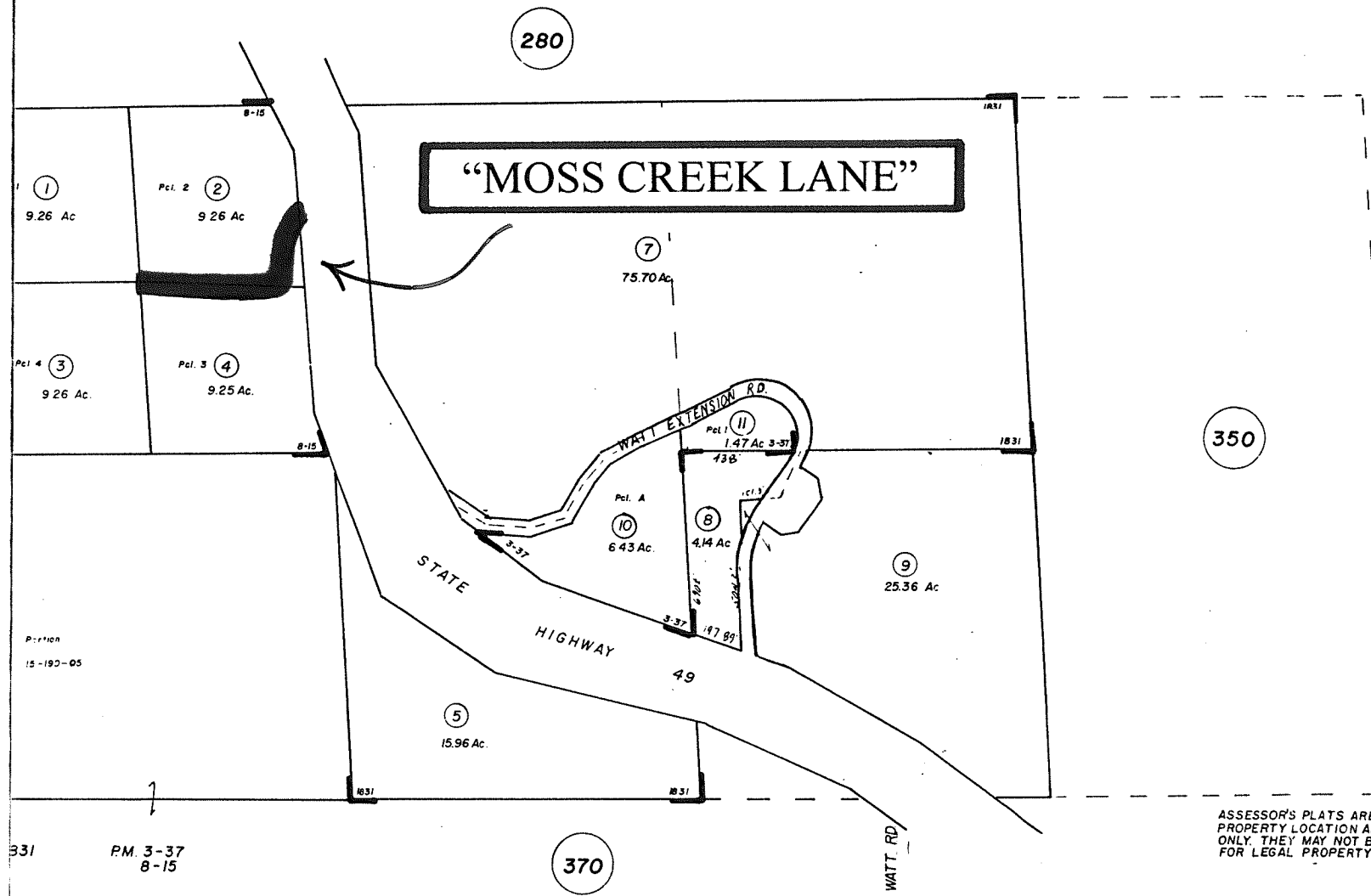

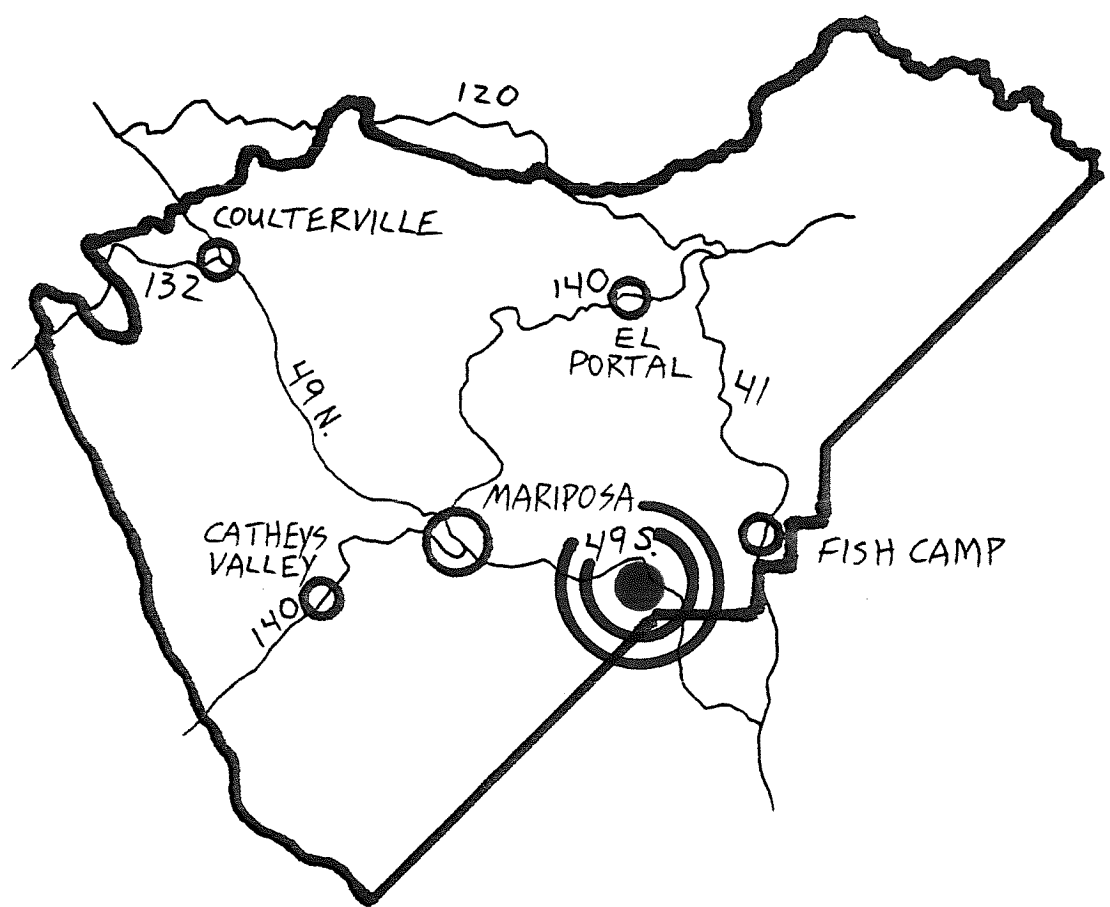
