SUBJECT: HEAD START CONTINUING APPLICATION

Head Start regulations require that applications for continuing Programs be submitted 90 days prior to the beginning of the Program Year. Since the Mariposa County Head Start Program Year is March 1st through February 28th, the "continuing application" is due on December 1st.

In addition to the Board of Supervisors, approval of the Parent Policy Council is required to submit the application. PPC approval was provided on November 8, 1994. Your approval of the application only continues the existing Program. No staff or policy changes are proposed in the continuing application.

Funding in the amount of \$354,892 is allocated to Mariposa County based on an enrollment of 77 children: 20 in the Mariposa center, 20 in the Greeley Hill center, and 37 in the Home Base program. Currently, 77 children are enrolled in the Program with 12 children on the waiting list.

The local "match" consists solely of in-kind contributions from the parents (volunteers, materials preparation, etc) and the Mariposa County Unified School District (value of land donated for the centers and "special needs" services such as Speech Therapy). No cash or staff in-kind is proposed as "match".

The Head Start Program is entirely discretionary. If Federal funding were eliminated, the County has no obligation to continue the Program. All staff have certified that employment is contingent upon receipt of Head Start Federal funds.

Thank you for your approval of the Head Start continuing application.
