
WHEREAS, in 1985, NICK assumed the duties and responsibilities of the Mariposa Unit Manager and Lands Officer; and




WHEREAS, NICK's dedicated and exemplary service with the United States Forest Service will be sincerely missed and we congratulate him on his well-earned retirement;


