MARIPOSA COUNTY PLANNING COMMISSION


WHEREAS, PATTI REILLY, has served with distinction on the Mariposa County Planning Commission representing Supervisorial District I, from July 27, 1991, through and including November 23, 1994. During her term of office, PATTI served as Planning Commission Chair and Vice-Chair; and

WHEREAS, PATTI always took great pride in carrying out the numerous tasks and responsibilities of a Planning Commissioner, such as hearing and deciding the following: Permit applications for land uses or variances; appeals from an order, permit, requirement, decisions or determinations made by the Director of the Planning Department; tentative tract and parcel map applications; environmental impact reports, mining permits and reclamation plans; recommendations by the Planning Department staff on filing tentative notices of violation and certificates of compliance. In addition, hearing and providing recommendations to the Board of Supervisors on General Plan/Zoning Amendment applications, Commercial Industrial and Manufacturing Plans, Agricultural Preserve applications, Planned Residential Development applications and Development Agreements; and


WHEREAS, while serving on the Planning Commission, PATTI was involved with the following significant and often difficult issues and projects: Mariposa Town Planning Area Specific Plan Amendments, Adult Detention Facility, Wawona fence wars, Mariposa Redevelopment Plan, Mariposa Vista Estates project, gift deed violations, Highway 49 South Scenic Highway proposal, Terrace View Major Subdivision, BIC Farms Major Subdivision, Las Mariposas Planned Community Environmental Impact Report, Mariposa-Yosemite Airport Master Plan and Comprehensive Land Use Plan, Countywide Community/Economic Development Committee Final Report, Private Schools General Plan/Zoning Amendment, Monte Vista Estates Major Subdivision, Rocking W Ranch II Estates Major Subdivision, Yosemite Views Estates Major Subdivision, Reins Major Subdivision, Italian Acres Major Subdivision, Anthony Major Subdivision, Miner's Inn Resort Design Review appeal, Grace Community Church Use Permit and Variance, personal use airstrip regulations, Strahm Major Subdivision, Fairbanks Home Enterprise appeal, hearings for variances and appeals, and discussions regarding signs in Mariposa Town Planning Area.






DOUG BALMAIN, District II
