PASSED AND ADOPTED by the Mariposa County Board of Supervisors this 16th day of February, 1993, by unanimous vote.

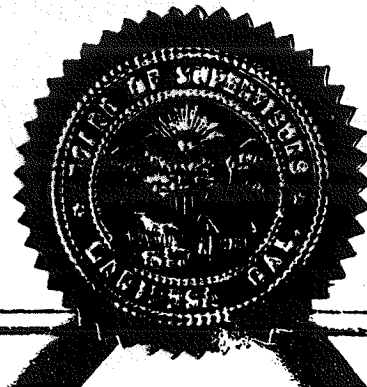

**A RESOLUTION RECOGNIZING DELLA HERN  
FOR HER OUTSTANDING SERVICE ON THE BOARD OF DIRECTORS  
FOR THE 35A DISTRICT AGRICULTURAL ASSOCIATION**

**WHEREAS, DELLA HERN** is a full-blooded member of the Paiute and Miwok Indian Tribes. **DELLA** was born at Mono Lake, California, and moved to Yosemite in 1932, graduating from grammar school in Yosemite. **DELLA** also attended Stewart Indian School in Stewart, Nevada. She is a member of the family of Captain Sam, who was her great great grandfather; and

**WHEREAS, DELLA** enlisted in the U.S. Women's Army Corps in 1944 and received an Honorable Discharge in 1946; and

**WHEREAS, DELLA** is an artisan in Indian handiwork. She served on the Fair Board of Directors from 1980 to 1992, during which time she worked on various sub-committees and supervised the arts and crafts, photography, and floriculture buildings during several different fairs. **DELLA** also conducted demonstrations on Indian crafts during the fair; and

**WHEREAS, DELLA** has served the Mariposa community in many areas:

- 1967-1971 - Member, Mariposa County School District Advisory Committee
- 1969 - Chairman, Mariposa Grand Jury
- 1969-1972 - Member, Economic Development Committee for Mariposa County
- 1970 - John C. Fremont Hospital Volunteer
- 1971-1974 - Member, Soroptimist International of Mariposa County
- 1979-1982 - Member, Democratic Central Committee
- 1980-1991 - Board of Directors, Mariposa County Arts Council
- 1990-Present - Member, Mariposa Historical Society
- 1990-1993 - Member, Mental Health Advisory Board
