RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes ___ No ___)
REQUEST THAT THE BOARD AUTHORIZE THE CHAIRMAN SIGN THE ATTACHED CONTRACTS WITH CAL BOATING FOR THE PURCHASE OF A REPLACEMENT RESCUE BOAT FOR USE IN THE COUNTY. THE ORIGINAL RUBBER BOAT THAT THE SHERIFF NOW HAS IS UNSAFE FOR THE RESCUE ROLE ON THE MERCED RIVER. THE STATE HAS AGREED TO FUND \$7,000.00 TO REPLACE IT AND THE TRAILER. WITH THE RETURN OF NORMAL WATER FLOW ON THE MERCED IT IS ANTICIPATED THAT THERE WILL BE RESCUE REQUIREMENTS ON THE RIVER. WITH THE STATE FUNDING THERE IS NO COST TO THE COUNTY. THE \$7,000 WILL HAVE TO BE ADDED BY BUDGET ACTION TO THE BOATING SAFETY BUDGET. THAT ACTION IS ATTACHED.
