MARIPOSA COUNTY RESOLUTION NO. 93-246

WHEREAS, VYNOMMA BROWN (NOMMIE) originally joined the staff of the Health Department in March of 1985 and submitted her resignation for personal reasons effective April 19, 1993; and

WHEREAS, during that time NOMMIE implemented and oversaw the enforcement of State regulations applicable to underground fuel storage tanks for the County of Mariposa; and

WHEREAS, NOMMIE became known to underground tank owners in the County as a County employee who directed her efforts toward assisting and helping owners in understanding and coming into compliance with applicable regulations utilizing her ample sense of humor in the process; and

WHEREAS, working with professional staff at the Health Department, she was instrumental in bringing a focus on, and resolution to, some significant environmental impacts surrounding underground storage tanks under the jurisdiction of the Department of the Interior and other governmental agencies; and

WHEREAS, NOMMIE leaves County service with the Underground Tank permitting program in 100% compliance with State law.

NOW, THEREFORE, BE IT RESOLVED that upon her retirement from County service, the Board of Supervisors does recognize and thank VYNOMMA BROWN for her contributions to the County which have resulted in protection of one of Mariposa County's most prized resources: its environment.
