**A RESOLUTION AFFORDING SPECIAL RECOGNITION TO IRENE JOHNSON**

**WHEREAS**, the month of May is Older American's Month, and Mariposa County wishes to extend special recognition to IRENE JOHNSON; and

**WHEREAS**, IRENE came to Mariposa in 1973 and went to work for the Mariposa Gazette where she had the opportunity to learn about and publicize the needs of seniors in the County; and

**WHEREAS**, IRENE took it upon herself to learn about the Older Americans Act and how it could be used in Mariposa County for the benefit of the elderly; and

**WHEREAS**, IRENE was instrumental in the development of a transportation system for seniors -- a bus so those who were no longer able to drive could get to the doctor, grocery store or wherever they needed to go without having to rely on someone else; and

**WHEREAS**, IRENE attended numerous Board of Supervisors meetings, transit needs hearings, revenue sharing hearings and many other public hearings regarding health planning and services, funding, etc., in pursuit of services for seniors; and

**WHEREAS**, IRENE traveled to Merced, Fresno and Sacramento; and to Amador, Alpine, Calaveras and Tuolumne Counties in pursuit of her objective; and

**WHEREAS**, some of her activities include first Chairman of the Van Advisory Committee; Charter Chairman of the Mariposa County Commission on Aging; Charter member and Chairman for three consecutive years of the Area Agency on Aging Advisory Council; five years on the CETA Regional Planning Committee, five years on the John C. Fremont Hospital Building and Planning Committee, six years on the Home Health Advisory Board, six years on the Mental Health & Drug Abuse Board; charter and current parliamentarian of the Mariposa Golden Agers, Inc., and secretary for two years; Chairman of the Mariposa Senior Network; Chairman of the Adult Day Health Care Planning Council and Long Term Care Committee, Master Plan Housing Element Committee, and Selection Committee for Senior Monitor; four years as Chairman on the Health Systems Agency for United States Region 9 which includes Fresno, Kings, Madera, Mariposa and Tulare Counties; and

**WHEREAS**, in 1985, the 20th anniversary of the Older Americans Act, IRENE received a citation "In Recognition and Appreciation of Outstanding Service to Older Americans" from the Administration on Aging, Office of Human Development Services, Department of Health and Human Services, Region IX; and

**WHEREAS**, some of the fruits of her, and her contemporaries, labor include a Senior Assistance Program in Mariposa County, State, Federal and local funding for senior transportation, CETA funding for a bus driver and kitchen help at the Senior Nutrition Site, State, Federal and local funding for the operation of a Senior Nutrition Site in Mariposa and in Greeley Hill, and a \$67,000 State Grant, co-written with the late Helen Green, for the Mariposa Golden Agers, Inc., Seniors Activities Center.

**NOW, THEREFORE, BE IT RESOLVED** by the Mariposa County Board of Supervisors, a political subdivision of the State of California, that IRENE JOHNSON is recognized for her many accomplishments for the senior citizens of Mariposa County.


