Recommend resolution authorizing Chairman to sign agreement proposed by Riggs Ambulance Service with the following modifications: 1. Include Paragraph I on Attachment B; 2. Replace "9 Reimbursement for Losses" with Paragraph II on Attachment B; 3. Include Paragraph II on Attachment B; 4. Include under "11 Reports #A.(1)" the following: "11A(1)(a) responded to by Mariposa units" and "11A.(1)(b) responded to by Merced units"; and 5. Include "Exhibit C". Paragraph I verbiage was in prior contracts (with the additional words "personnel files") and is important to the County for information and auditing, as is the data requested per Paragraph II, the data breakdown under 11A.(1)., and "Exhibit C". Paragraph III was in all prior contracts.

Recommend that 1986 Ford VIN #2GCEG255G4128506 be signed over to Riggs Ambulance Service. The County already has in its possession 1982 Ford, VIN # 1FTHE34Z6CHA57033, deeded to it by Riggs Ambulance Service several years ago.
