**WHEREAS**, the Mariposa County Board of Supervisors supports the request of the Merced Fly Fishing Club and Fly Fishers for Conservation (Fresno) to reopen the winter fishing season on the Merced River by revising the Sport Fishing Regulations , and

**WHEREAS**, the Mariposa County Board of Supervisors urges the California State Fish and Game Commission to adopt this revision;

**NOW THEREFORE, BE IT HEREBY RESOLVED** by the Board of Supervisors of Mariposa County, a political subdivision of the State of California, that the County of Mariposa, supports the following revision to the Sport Fishing Regulations:

**"Section 7.50(b)(1127)**

(c) Mainstem of the Merced River downstream from the Foresta Bridge to the upper end of McClure Reservoir.

Last Saturday in April through November 15	5 fish per day 10 in possession
November 15 through the last Friday in April	2 fish per day 2 in possession"


