

MARIPOSA COUNTY RESOLUTION No. 84-11

A RESOLUTION INCREASING FILING FEES
IN SPECIFIC CIVIL ACTIONS OR PROCEEDINGS
IN SUPERIOR COURT AND JUSTICE COURT
PURSUANT TO

GOVERNMENT CODE SECTION 68090.7

RESOLVED by the Board of Supervisors of Mariposa County,
a political subdivision of the State of California as follows:

WHEREAS, the Legislature has recently enacted Section
68090.7 of the Government Code which provides for Counties, by
appropriate Resolution, to charge a fee of ONE DOLLAR (\$1.00) in
addition to the fees fixed by Government Code Sections 26820.4,
26826, 26827, 72055, and 72056 for filings in civil action or
proceedings as follows:

"(a) The first paper and papers transmitted from
another court, as specified in Section 26820.4 and 72055.

(b) The first paper on behalf of an adverse
party, as specified in Section 26826 and 72056.

(c) A petition or other paper in a probate,
guardianship, or conservatorship matter as specified by
Section 26827.

The fee shall not apply to adoptions, appeals from an
inferior court, or motions.

Except as otherwise specified by law all fees collected
under this section shall be transmitted to the county trea-
surer and an amount equal thereto shall be used exclusively
to pay the costs of automating the county clerk's and muni-
cipal and justice court recordkeeping system or the conver-
sion of the court's document system to micrographics or
both."

NOW, THEREFORE, the Board of Supervisors of Mariposa County does hereby resolve to increase the filing fee by ONE DOLLAR (\$1.00) for those specific filings as described above, for the Superior Court and Justice Court of Mariposa County.

AND RESOLVED FURTHER, that the County Treasurer and County Auditor/Recorder are hereby directed to establish a fund entitled, "County Clerk's and Justice Court's Micrographics Fund", for the purpose of collecting said monies and disbursing said monies for those specific uses.

AND FURTHER RESOLVED that this Resolution shall be become effective immediately upon adoption.
