

MARIPOSA COUNTY RESOLUTION No. 84-67

A RESOLUTION RELATIVE TO  
MONTE VISTA ESTATES MAJOR SUBDIVISION  
RECORDATION OF FINAL MAP AND  
ACCEPTANCE OF FIRE STATION SITE

WHEREAS, the road construction work on the Monte Vista Estates Major Subdivision is complete with the exception of the road oiling, and

WHEREAS, road oiling is best done during the warm summer months, and

WHEREAS, the Mariposa County Road Commissioner requests the County to proceed with this matter under the specific conditions as outlined below;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Mariposa County, a political subdivision of the State of California, as follows:

1. A deferment of the road oiling for the roads within Monte Vista Estates is hereby approved, subject to the Developer making a cash deposit, in the amount of \$7,000.00 payable to Mariposa County, to cover said deferment. The Chairman is authorized to execute an agreement, approved by County Counsel, on the deferment of the road oiling.
2. The County accepts the proposed fire station site, subject to County obtaining unencumbered fee title to the site, and authorizes the Chairman to execute any and all documents, if necessary, relating to same.
3. The final map is hereby approved and County accepts the rights of way along Triangle Road, which is a County road, so marked as offered for dedication, all drainage

1 and public utility easements noted on map and a one-foot-wide


