

1 MARIPOSA COUNTY RESOLUTION No. 85-216

2 POLICY RELATIVE TO WORK  
3 BY COUNTY ROAD DEPARTMENT

4 WHEREAS, the Board of Supervisors of Mariposa County  
5 has allowed the Mariposa County Road Department to perform  
6 road work, for a fee, for private landowners when the Road  
7 Department was able to provide such work, and

8 WHEREAS, as a result of increased liability exposure  
9 and increased insurance costs, the Board hereby deems that it  
10 is no longer in the best interest of the public to allow the  
11 Road Department to perform such work for private landowners,  
12 and

13 WHEREAS, the Board desires to adopt a policy regarding  
14 work to be performed by the County Road Department;

15 NOW THEREFORE, BE IT RESOLVED by the Board of Super-  
16 visors of Mariposa County as follows:

17 1. The Mariposa County Road Department shall perform  
18 road work on roads contained in the County Road System, as  
19 defined in the California Streets and Highways Code.

20 2. The County Road Department may perform work,  
21 for a fee, for other County Departments, including the Board  
22 of Supervisors and Public Utilities. The Road Department  
23 shall be reimbursed for doing work for any County Department,  
24 including the Board of Supervisors, and any Public Utility.

25 3. Under no circumstances shall the County Road  
26 Road Department perform work for private individuals or  
27 organizations except in an emergency as described below.

28 4. The County Road Department may, in an emergency

1 situation, take emergency action on property owned by private  
2 individuals or organizations. Work done on an emergency  
3 basis shall be evaluated on a case by case basis and shall  
4 only be authorized by the Road Commissioner, or in his  
5 absence, an individual authorized by him to take action.  
6 Regardless of the emergency situation, no work shall be done  
7 hereunder if it is not in the public interest and for the benefit  
8 of the public at large.
