AMENDING RESOLUTION NO. 83-175
RE: CARRY-OVER OF COMPENSATORY TIME

WHEREAS, Section 8.03 of the Mariposa County Personnel Policy and Procedures Handbook provides that:

"Compensatory time shall be taken within each fiscal year period in which it is earned. If accrued compensatory time is not taken within the fiscal year period, it shall be paid to the employee at the end of said fiscal year."
