

A G R E E M E N T

WEIGHTS AND MEASURES

4 THIS AGREEMENT made and entered into the 4th day of
5 May, 1982, by and between the County of Mariposa, herein
6 after designated as MARIPOSA; and the County of Merced, herein
7 after designated as MERCED.

8 WHEREAS, MARIPOSA is required pursuant to Business and Pro-
9 fessions Code Section 12200 to provide for the office of the
10 County Sealer of Weights and Measures and at the present time is
11 unable to fill said office; and,

12 WHEREAS, public agencies are authorized to contract with
13 each other for the joint exercise of any common power under Arti-
14 cle 1, Chapter 5, Provision 7, Title 1 of the Government Code of
15 the State of California; Sections 6500-6514 and,

16 WHEREAS, it is important to the interests of the people of
17 the County of Mariposa and State of California that weighing and
18 measuring devices be inspected regularly so as to insure their
19 accuracy.

20 NOW, THEREFORE, it is agreed as follows:

21 1. MERCED agrees to provide the services of Sealer of
22 Weights and Measures within the boundaries of the County
23 of Mariposa for the purpose of inspecting, weighing and
24 measuring devices in use serving the public within said
25 County of Mariposa in the same manner as said services
26 are provided in the County of Merced upon the following
27 conditions.

28 a. That the Sealer of Weights and Measures of Merced

1 County will be compensated in that pro rata share of his
2 salary which he receives for providing said services
3 within the County of Merced. Merced County will be re-
4 imbursemented for any travel costs of the Sealer incurred
5 under this AGREEMENT at the official mileage rates
6 adopted by the County of Merced; reasonable reimburse-
7 ment will also be paid for specialized equipment of
8 Merced County used under this AGREEMENT. Should it
9 become necessary, MERCED may hire a qualified person to
10 perform said services and such person shall be paid at
11 the rate of \$8.94 per hour plus mileage.

12 b. Further that said pro rata share of said salary
13 shall be reimbursed to the County Treasurer of Merced
14 County upon the filing of a proper claim with Mariposa
15 County and shall be paid according to standard Mariposa
16 County procedures.

17 c. MARIPOSA agrees that it will require all wholesale
18 and retail establishments which serve the public within
19 the boundaries of Mariposa County to submit to such in-
20 spection and to comply with any State of California or
21 County of Mariposa or other law, rule, regulation or
22 order which may result from this inspection of weighing
23 and measuring devices, as aforesaid.

24 d. This AGREEMENT shall continue from the date of its
25 execution for a period of one (1) year; and may be ter-
26 miniated by either party upon written notice within
27 thirty (30) days.
