 on matter expressed, does hereby agree to furnish to the State services and materials, as follows:

Amendment No. 3

That this agreement to provide Energy Crisis Intervention Program (ECIP) services to
 eligible participants throughout the State, entered into on November 16, 1981, and
 amended on March 1, 1982, and further amended on June 1, 1982, is further amended as
 follows:

1. That the term of this agreement be extended from August 31, 1982, through Sep-
 tember 30, 1982.
2. That Article 3.A. be decreased from 45,000 to 31,000, to reflect a decrease
 of 14,000.
3. That Attachment A Budget be replaced in its entirety by Attachment A Budget
 revised August 1, 1982 in accordance with the decrease.


All remaining terms and conditions of this agreement shall remain unchanged


