5 WHEREAS, the California Land Conservation Act of 1965 provides for
6 the establishment of Agricultural Preserves within the County of Mariposa
7 shall be filed and kept current by the County Recorder and;

8 WHEREAS, Resolution 78-16 adopted the "Mariposa County Agricultural
9 Preserve Map" which shows those established Agricultural Preserves in the
10 County of Mariposa, and;

11 WHEREAS, it is necessary to amend the Agricultural Preserve Map to
12 reflect additional preserve areas,

13 NOW THEREFORE BE IT RESOLVED that the Board of Supervisors, County
14 of Mariposa, do hereby adopt the "Mariposa County Agricultural Preserve Map"
15 Amendment, attached hereto as Exhibit "A" which shows those established
16 Agricultural Preserves in the County of Mariposa as amended;

17 BE IT FURTHER RESOLVED that the Mariposa County Agricultural Preserve
18 Map, as amended be filed with the Mariposa County Recorder and kept on a
19 current basis.


