

1 MARIPOSA COUNTY RESOLUTION NO. 81-42

2 A RESOLUTION TO APPROVE THE PRIORITY PLAN FOR
3 EXPENDITURE OF FUNDS UNDER THE CALIFORNIA PARK-
LANDS ACT OF 1980.

4 WHEREAS, the California Parklands Act of 1980 requires
5 that each County shall consult with all cities and districts
6 within the County which are eligible to receive grant funds
7 under provisions of Section 5096.156 of the Act and develop and
8 submit to the State for approval a priority plan for expenditure
9 of the county's allocation; and

10 WHEREAS, said priority plan shall reflect consideration of
11 deficiencies within the county in the preservation of historical
12 resources and natural landscapes as well as in the provision of
13 recreational areas and facilities; and

14 WHEREAS, said priority plan shall also reflect regional
15 park or open-space needs as well as community and neighborhood
16 park and recreation needs in any county in which a regional
17 park or open-space district is wholly or partially located; and


18 WHEREAS, the County of Mariposa has no incorporated cities
19 and only one district authorized by law to dispense recreational
20 services, which district has been consulted for input on expen-
21 diture priorities; Mariposa County has prepared a priority plan
22 for expenditure of the county's allocation which reflects
23 deficiencies and needs required by the Program, said priority
24 plan being attached hereto and marked Exhibit "A";


25 NOW THEREFORE BE IT RESOLVED by the Board of Supervisors
26 of Mariposa County that Mariposa County does hereby approve the
27 priority plan for the expenditure of the county's allocation of
28 funds under the California Parklands Act of 1980; and

1 BE IT FURTHER RESOLVED that the County Clerk acting as
2 Ex Officio Clerk of the Board is hereby authorized and directed
3 to forward a certified copy of this resolution along with
4 Exhibit "A" to the State Department of Parks and Recreation.

EXHIBIT "A" - 1980 PARKLANDS ACT

Mariposa County Allocation, \$100,000.00

STATE BEACH, PARK, RECREATIONAL & HISTORICAL FACILITIES

Projects are not limited in any priority order

WOODLAND PARK

Development of this site would include an all-purpose sports field, parking area, water, sewer and restroom facilities.

MARIPOSA PARK COMMUNITY CENTER

Development of a Community Building in Mariposa Park as an indoor location for recreation programs for youth, Seniors and others is a local priority.

COULTERVILLE POOL

Renovation of the pool and bathhouse may include replaster and retile of the pool, reconstruction of the bathhouse, remodeling restrooms and removal and replacement of the concrete decking.

MIDPINES PARK

The culmination of 18 years of work in finalizing a Park site for the area by purchase of property currently leased from the U.S. Forest Service.
