

1 MARIPOSA COUNTY RESOLUTION NO. 81-100
2 A RESOLUTION ESTABLISHING THE LOCALLY
3 DESIGNATED AGENCY FOR THE CALIFORNIA
4 ARTS COUNCIL LOCAL PARTNERSHIP PROGRAM
5 AS THE BOARD OF SUPERVISORS

6 WHEREAS, the Board of Supervisors has received the Mariposa
7 County Plan for the Arts as prepared by the County Arts Council,
8 a temporary planning agency, and now desires to establish a locally
9 designated agency for implementation of said plan;

10 NOW THEREFORE IT IS RESOLVED by the Board of Supervisors of
11 Mariposa County, a political subdivision of the State of California,
12 as follows:

13 1. The Board of Supervisors shall be the designated agency
14 for the purpose of accepting grants from the California Arts
15 Council, until such time as a Mariposa County Arts Council is
16 legally formed as a non-profit corporation and found accept-
17 able by the Board of Supervisors;

18 2. The Board of Supervisors shall review the proposed bylaws
19 and the formation of a non-profit corporation as the Mariposa
20 County Arts Council and shall consider at a future date the
21 designation of such Council as the local designee for Arts
22 grants.

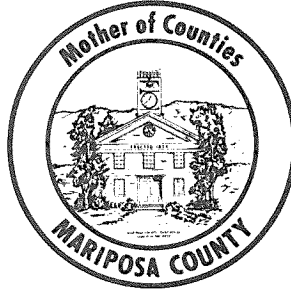
