A. Statement of Purpose

The purpose of the CETA Program is to provide training and employment opportunities to the economically disadvantaged unemployed and under-employed; and to increase their earned income, employability and economic self sufficiency. This shall be accomplished through a system that coordinates with other employment and training programs.

B. Geographic Area/Population/Labor Market

The county of Mariposa, comprising 931,200 acres or 1,455 square miles, is situated in the approximate center of California. It is bordered on the west by Merced County, on the south by Madera County, the north by Tuolumne County, and on the east by Mono County. Within its borders are parts of two great National Forests, Stanislaus and Sierra, and the largest part of Yosemite National Park. From this high country, the Merced and Chowchilla Rivers flow to the west into the San Joaquin Valley. Mariposa has varied topography covering a range of elevations from a little over 300 feet at several points to over 11,000 feet atop some mountain peaks within Yosemite National Park.

The climate of Mariposa County is characterized by warm summers, mild winters, little rainfall during the late spring, summer and early fall, and comparatively heavy precipitation during the winter months. Some 85 to 90 percent of annual precipitation in Mariposa occurs during the period of November 1, to April 30. It varies from 10 inches at the lowest elevation to over 50 inches at elevations of 7,500 feet or more.

Recreation and tourism are Mariposa's major industries, generating most of the income and employment in the county. Yosemite National Park is the primary tourist attraction in the area, registering over two and one-half million visitors annually. Business involved in lodging, food service and retail trade are the heart of Mariposa's economy. In addition to the Park, various community centers, county parks and recreational sites are utilized by thousands of tourists yearly. Fishing, hunting, boating, and a variety of water sports are available at numerous reservoirs throughout the county.

The Department of Finance estimated that the population of Mariposa County grew from 6,015 in 1970 to 11,300 in 1980, an 87.9 percent increase. California's population increased at a rate of only 18.3 percent during the same period. Virtually all of Mariposa County's rapid population increase has been the result of migration into the county, rather than internal growth.

Mariposa County's population is expected to continue increasing faster than the state, reaching about 12,600 by 1982.

F. Political Activity

It will comply with the provisions of the Hatch Act which limit the political activity of certain State and local government employees and with the Brown Act in relation to holding public meetings.

G. Selection of Service Deliverers

Subgrantee will give special consideration to programs with demonstrated effectiveness in the delivery of employment and training services.

H. Monitoring Provisions

CBOS and/or Department of Labor shall have the right to observe and monitor all conditions and activities of the CETA program. Subgrantee shall maintain program and fiscal records and make such documents readily accessible to CBOS and/or DOL personnel.

III. RECIPIENT CERTIFICATION

A. Certification

The recipient certifies that the information in this subagreement is correct to the best of its knowledge and belief.

B. Legal Authority

Documentation of legal authority to sign this BOS/CA and/or these assurances and certifications is evidenced via a resolution, motion, or similar action duly adopted and passed as an official act of the governing body. Such documentation directs and authorizes the person identified as the official representative of the subgrantee to submit and act in connection with this subagreement and to provide such additional information as may be required.

C. Subgrants

All signators to subgrants submitted under this BOS/CA will be duly authorized by the governing body to sign and act in connection with the subgrant.
