

1 MARIPOSA COUNTY RESOLUTION NO. 81-192

2 RESOLUTION OF THE BOARD OF SUPERVISORS OF THE
3 COUNTY OF MARIPOSA APPROVING PARTICIPATION IN THE
4 1981-82 STATE/LOCAL PARTNERSHIP PROGRAM, DESIGNA-
5 TING THE LOCAL ARTS PLANNING AGENCY, AND APPROVING
6 AND AUTHORIZING EXECUTION OF A GRANT CONTRACT
7 WITH THE CALIFORNIA ARTS COUNCIL

8 WHEREAS, the California Arts Council and the California
9 State Legislature have established a State/Local Partnership
10 Program (the "Program") designed to encourage local cultural
11 planning and decisionmaking and to reach previously underserved
12 constituencies; and

13 WHEREAS, pursuant to the 1980-81 Program Guidelines, the
14 Board of Supervisors of the County of Mariposa (the "Board of
15 Supervisors") designated Mariposa County Arts Council Inc. as
16 the Local Arts Planning Agency under the Program for the purpose
17 of preparing a comprehensive community arts plan; and

18 WHEREAS, the Board of Supervisors and Mariposa County Arts
19 Council, Inc. (together defined as the "Local Partner") are now
20 eligible to apply for and receive a nonmatched block grant of
21 \$12,000 for the purpose of completing the analysis of data
22 gathered in the arts planning process initiated under the 1980-81
23 Program and for the purpose of establishing a grant review mecha-
24 nism with a methodology for allocating additional Program funds;

25 NOW, THEREFORE, THE BOARD OF SUPERVISORS OF THE COUNTY OF
26 MARIPOSA DOES HEREBY RESOLVE AS FOLLOWS:

27 Section 1. The Board of Supervisors hereby approves parti-
28 cipation by the Local Partner, designated for 1981-82 as itself
and Mariposa County Arts Council, Inc., in the 1981-82 State/
Local Partnership Program.
