

1 MARIPOSA COUNTY RESOLUTION NO. 81-252

2 AMENDING THE PERSONNEL POLICIES AND
3 PROCEDURES HANDBOOK REGARDING LEGAL
4 HOLIDAYS

5 RESOLVED by the Board of Supervisors of Mariposa County,
6 after duly meeting and conferring with authorized representatives
7 of employee organizations, as follows:

8 1. Sections 9.01 and 9.02 of the Personnel Policies and
9 Procedures Handbook are amended to read as follows:

10 "9.01 LEGAL HOLIDAYS

11 The following are hereby established as legal holidays in the
12 County of Mariposa pursuant to Government Code Sections 6700,
13 18025, and 18025.1.:

- 14 1. Every Sunday
- 15 2. January 1st
- 16 3. January 15th known as "Dr. Martin Luther King, Jr. Day"
- 17 4. February 12th known as "Lincoln Day"
- 18 5. Third Monday in February
- 19 6. Last Monday in May
- 20 7. July 4th
- 21 8. First Monday in September
- 22 9. September 9th known as "Admission Day"
- 23 10. Second Monday in October known as "Columbus Day"
- 24 11. November 11th known as "Veterans Day"
- 25 12. December 25th
- 26 13. Every day appointed by the President or Governor for a
27 public fast, thanksgiving, or holiday, provided each
28 such day is specified as a paid holiday by the President
or Governor for public employees. The Thursday in Novem-
ber appointed as Thanksgiving Day shall be a legal holi-
day in Mariposa county;

14. Every employee shall be entitled to take as a holiday the Friday preceding any Saturday on which one of the holidays set out in 2, 3, 4, 7, 9, 11, and 12 above occurs.

15. Every employee shall be entitled to take as a holiday the Monday following any Sunday on which one of the holidays set out in 2, 3, 4, 7, 9, 11, and 12 above occurs.

9.02 PERSONAL HOLIDAYS

9.02.01 Personal Holiday

Every employee shall be entitled to one personal holiday per calendar year pursuant to Government Code Section 18025.1.

9.02.02 Additional Holidays

Every employee shall be entitled to take one of the following additional holidays, subject to the employee's choice and prior approval by the employee's department head:

1. The day after Thanksgiving
2. The day before Christmas (December 25th)
3. The day before New Year's Day (January 1st)."

2. This Resolution shall become effective on the same date that Ordinance No. 574 becomes effective.



STATE HOLIDAYS—MARTIN LUTHER KING DAY

CHAPTER 325

ASSEMBLY BILL NO. 312

LEGISLATIVE COUNSEL'S DIGEST

Existing law provides that specified days are state holidays.

This bill would designate January 15th "Dr. Martin Luther King, Jr. Day," and would make this day a state holiday.

The people of the State of California do enact as follows:

SECTION 1. Section 37220 of the Education Code is amended to read:

37220.

Except as otherwise provided the public schools shall continue in session or close on specified holidays as follows:

(a) The public schools shall close on January 1st, January 15th known as "Dr. Martin Luther King, Jr. Day," February 12th known as "Lincoln Day," the third Monday in February known as "Washington Day," the last Monday in May known as "Memorial Day," July 4th, the first Monday in September known as "Labor Day," November 11th known as "Veterans Day," that Thursday in November proclaimed by the President as "Thanksgiving Day," and December 25th.

(b) The Governor in appointing any other day for a public fast, thanksgiving, or holiday may provide whether the public schools shall close on the day. If the Governor does not provide whether the public schools shall close, they shall continue in session on all special or limited holidays appointed by the Governor, but shall close on all other days appointed by the Governor for a public fast, thanksgiving, or holiday.

(c) The public schools shall close on every day appointed by the President as a public fast, thanksgiving, or holiday, unless it is a special or limited holiday.

(d) The public schools shall continue in session on all legal holidays other than those designated by or pursuant to this section and shall hold proper exercises commemorating the day.

(e) When any of the holidays on which the schools would be closed fall on Sunday, the public schools shall close on the Monday following.

(f) When any of the holidays on which the schools would be closed fall on Saturday, the public schools shall close on the preceding Friday, and such Friday shall be declared a state holiday.

(g) If any holiday on which the public schools are required to close pursuant to subdivision (a) occurs under federal law on a date different than the date specified in subdivision (a), the governing board of any school district may close the public schools of the district on the date recognized by federal law and maintain classes on the date specified in subdivision (a).

(h) Nothing in this section is to be interpreted as authorizing a school district governing board to maintain schools in its district for a lesser number of days during the school year than the minimum established by law.

SEC. 2. Section 37227.5 of the Education Code is amended to read:

37227.5.

All public schools and educational institutions throughout the state shall, on * * * the first school day occurring before or after the date each year * * * on which the Dr. Martin Luther King, Jr., holiday occurs, hold suitable exercises commemorating, and directing attention to the history of, the civil rights movement in the United States, and particularly the role therein of Dr. Martin Luther King, Jr.

SEC. 3. Section 6700 of the Government Code is amended to read:

6700.

The holidays in this state are:

(a) Every Sunday.

(b) January 1st.

(c) January 15th, known as "Dr. Martin Luther King, Jr. Day."

(d) February 12th, known as "Lincoln Day."

* * * (e) The third Monday in February.

* * * (f) The last Monday in May.

* * * (g) July 4th.

* * * (h) First Monday in September.

* * * (i) September 9th, known as "Admission Day."

* * * (j) The second Monday in October, known as "Columbus Day."

* * * (k) November 11th, known as "Veterans Day."

* * * (l) December 25th.

* * * (m) Good Friday from 12 noon until 3 p. m.

* * * (n) Every day appointed by the President or Governor for a public fast, thanksgiving, or holiday.

Except for the Thursday in November appointed as Thanksgiving Day, this subdivision shall not apply to a city, county, or district unless made applicable by charter, or by ordinance or resolution of the governing body thereof.

If the provisions of this section are in conflict with the provisions of a memorandum of understanding reached pursuant to Chapter 12 (commencing with Section 3500) of Division 4 of Title 1, the memorandum of understanding shall be controlling without further legislative action, except that if such provisions of a memorandum of understanding require the expenditure of funds, the provisions shall not become effective unless approved by the Legislature in the annual Budget Act.

The board of supervisors of any county may by ordinance or resolution alter the date of any holiday designated in (c), (d), (e), (g), (h), (j), (l), (j), or * * * (k) applicable to the superior, municipal, and justice courts in such county. Provided, however, that any such altered holiday shall not be considered a holiday or a day on which a court is not in session for purposes of taking criminal defendants before a magistrate as provided in Section 823 of the Penal Code.

SEC. 4. Section 6701 of the Government Code is amended to read:

6701.

If January 1st, January 15th, February 12th, July 4th, September 9th, November 11th, or December 25th falls upon a Sunday, the Monday following is a holiday. If November 11th falls upon a Saturday, the preceding Friday is a holiday. Approved and filed Sept. 3, 1981.

SECTION 9: HOLIDAYS

Old Section

9.01 LEGAL HOLIDAYS

The following are hereby established as legal holidays in the County of Mariposa pursuant to Government Code Sections 6700, 18025, and 18025.1:

1. Every Sunday
2. January 1st
3. February 12th known as "Lincoln Day"
4. Third Monday in February
5. Last Monday in May
6. July 4th
7. First Monday in September
8. September 9th known as "Admission Day"
9. Second Monday in October known as "Columbus Day"
10. November 11th known as "Veterans Day"
11. December 25th
12. Every day appointed by the President or Governor for a public fast, thanksgiving, or holiday.
13. Every employee shall be entitled to take as a holiday the Friday preceding any Saturday on which one of the holidays set out in 2, 3, 6, 8, 10, and 11 above occurs.
14. Every employee shall be entitled to take as a holiday the Monday following any Sunday on which one of the holidays set out in 2, 3, 6, 8, 10, and 11 above occurs.

9.02 PERSONAL HOLIDAYS

9.02.01 Personal Holiday

Every employee shall be entitled to one personal holiday per calendar year pursuant to Government Code Section 18025.1.

9.02.02 Additional Holidays

Every employee shall be entitled to take one of the following additional holidays subject to the employee's choice and prior approval by the employee's department head:

- a. The day after Thanksgiving
- b. The working day before or the first working day after Christmas (December 25th)
- c. The working day before or the first working day after New Year's Day (January 1st)
