That agreement pertaining to a low-income Weatherization Program, entered

1. In Article 8 the December 31, 1981, date is changed to March 31, 1982.
2. In Article 9 the total amount payable is changed from \$30,000 to \$ 24,000, a decrease of \$ 6,000.
3. Attachment A is replaced in its entirety with Attachment A dated December 30, 1981, attached hereto and incorporated herein by reference.
4. Attachment E is replaced in its entirety with Attachment E dated December 30, 1981, attached hereto and incorporated herein by reference.

All other terms and conditions shall remain unchanged.
