

A RESOLUTION EXPRESSING APPRECIATION TO ALL THOSE

WHEREAS, the County of Mariposa is required by State Law to have an adequate General Plan program of review and update, and;

WHEREAS, the Mariposa County Planning Staff initiated this review and began preliminary preparation for the Update in 1978, and in turn, worked diligently for two years in developing their recommendations for presentation to the Planning Commission and the Board of Supervisors in July of 1980; and,

WHEREAS, the Mariposa County Board of Supervisors and Planning Commission felt it necessary and desirable to form a committee consisting of their members and members of the Public at large to review the text of the General Plan;

WHEREAS, the General Plan Update Committee expressed extraordinary committment to their tasks by thoroughly reviewing the text of the Plan over a period of time spanning many months and countless hours of their personal time in order to present the finalized recommendations to the Board of Supervisors in late October of 1981; and,

WHEREAS, throughout the review of the draft General Plan Update, public review and comments were solicited from scores of interested community members and representatives of the public at large who spent many hours reviewing, studying, and commenting on the content of the draft Update, and;

WHEREAS, on November 3, 1981, the Board accepted the draft General Plan Update for formal public review and comment which lead to the beginning of the formal public review and comment period; which through a series of numerous public hearings, scores of citizens participated in presenting the Planning Commission and Board with their comments, thoughts, and recommendations.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Mariposa County Board of Supervisors would like to express their appreciation and gratitude to all the members of the County Planning Commission, County Planning Staff, County Counsel, other Agencies who took part in the Update, and the residents of Mariposa County at large for their committment of time and effort towards the preparation of a document that will guide the future growth and development of Mariposa County in a manner which is a credit to all present and future residents of the County.


