4 RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF MARIPOSA
5 ADOPTING A CONFLICT OF INTEREST CODE AS AMENDED BY THE STATE OF
6 CALIFORNIA FAIR POLITICAL PRACTICES COMMISSION PURSUANT TO
7 GOVERNMENT CODE SECTION 87103(b).

9 The Board of Supervisors of the County of Mariposa hereby
10 resolve as follows:

11 SECTION 1: ADOPTION OF CONFLICT OF INTEREST CODE.

12 In compliance with Section 87300 of the Government Code, the
13 Board of Supervisors hereby adopts this amended Conflict of
14 Interest Code.

15 SECTION 2: APPLICATION OF CODE.

16 This Conflict of Interest Code shall be applicable to members
17 of the County Board of Supervisors, whether acting as board members
18 or as members of any county board or commission.

19 SECTION 3: DISCLOSURE.

20 Members of the Board of Supervisors are required, pursuant
21 to Government Code Section 87200, to disclose investments,
22 interest in real property and income. No other or no additional
23 disclosure requirements are imposed by this Conflict of Interest
24 Code.

25 SECTION 4: CIRCUMSTANCES REQUIRING DISQUALIFICATION.

26 Any member of the Board of Supervisors, whether acting as
27 a board member or as governing board member or commissioner of
28 any County agency must disqualify himself or herself from making

1 or participating in the making of any decisions which will fore-
2 seeably have a material financial effect, distinguishable from its
3 effect on the public generally, on any economic interest, as
4 defined in Government Code Section 87103. No member shall be
5 prevented from making or participating in the making of any
6 decision to the extent his or her participation is legally re-
7 quired for the decision to be made.

8 SECTION 5: DEFINITIONS.

9 Except as otherwise indicated, the definitions contained in
10 the Political Reform Act of 1974 (Government Code Section 81000)
11 and regulations adopted pursuant thereto are incorporated in this
12 Conflict of Interest Code.

13 SECTION 6:

14 The County Clerk is directed to forward a certified copy of
15 this resolution to the Fair Political Practices Commission.
