3 RESOLUTION OF INTENTION TO ABANDON

6 BE IT RESOLVED that the Board of Supervisors of the

8 intention to abandon approximately .34 acres of public road

12 Mariposa County Records, thence S 0° 46' 00" W,  
13 100.70 feet; thence N 82° 26' 00" W, 125.96 feet;  
14 thence S 7° 31' 00" W, 125.00 feet; thence N 79°  
15 00' 00" W, 130.23 feet; thence S 62° 33' 30" E,  
181.98 feet; thence N 0° 46' 00" E, 318.26 feet;  
16 thence N 89° 14' 00" W, 20.00 feet to the point  
17 of beginning, said point being the terminal point  
18 of this description containing 0.34 acres more  
19 or less;

20 in accordance with the provisions of Streets & Highways Code,  
21 Section 956.8, et seq.

22 BE IT FURTHER RESOLVED that the Board of Supervisors  
23 intends that the abandoned portion shall not be replaced or  
24 relocated, and

25 BE IT FURTHER RESOLVED that it is hereby ordered that a  
26 public hearing to consider the question of abandonment be held  
27 on November 30th, 1976, at 2:00 p.m. o'clock,  
28 at the Board Room in the Courthouse, Town of Mariposa; and

BE IT FURTHER RESOLVED that the Clerk is hereby ordered  
to publish notice of hearing in the Mariposa Gazette for two  
weeks on the dates of November 18th, 1976 and  
November 25th, 1976, and to post notice of hearing
