## LEGAL NOTICE

Notice is hereby given that Project Operator(s) acting on behalf of Mariposa County have entered into an agreement with the Employment Development Department, Prime Sponsor in the Balance-of-State counties, for its share of a Federal grant allocated to administer the Title I program of the Comprehensive Employment and Training Act of 1973 (CETA). Mariposa County's share of this allocation is approximately \$62,000. The County's goal for utilizing these funds is to provide training and employment to the unemployed, underemployed, and economically disadvantaged.

During Fiscal Year 1975-76, ending June 30, 1976, \$49,237 of the total allocation will be expended to provide approximately 8 clerical and maintenance jobs at \$2.10 an hour for workers 18-70 years of age, and approximately 12 clerical and maintenance jobs at \$2.10 an hour for in-school youngsters aged 16-18. The balance of the funds, \$12,963, will be expended for the Summer Youth 1976 program.

Special attention for all of the above programs will be focused on Vietnam veterans, disadvantaged youth, unskilled workers and welfare recipients. Members of minority groups and women will also receive special attention.
