

1 BOARD OF SUPERVISORS - COUNTY OF MARIPOSA

2 RESOLUTION NO. 74-8

3 WHEREAS, on January 25, 1974, the State Highway Engineer
4 forwarded official notice of amounts due Mariposa County under
5 the Federal Aid Highway Acts, in accordance with the provisions
6 of Section 2208 and 2210.5 of the Streets and Highways Code,
7 as follows:

8 Federal Aid Secondary Funds \$81,872

9 State Highway Fund Money for Matching \$40,936

10 WHEREAS, Section 2211 of the Streets and Highways Code re-
11 quires the County within 60 days of receiving notice of the
12 Federal Aid Secondary apportionment and the apportionment of
13 matching money from the State Highway Fund to notify the State
14 Highway Engineer as to what amount of the apportionment the
15 County wishes to claim and to agree to provide any County money
16 as may be required to complete the financing of its selected
17 projects, and

18 WHEREAS, Section 2208 of the Streets and Highways Code pro-
19 vides that a county whose FAS apportionment is less than \$100,000
20 may exchange such FAS funds for an equal amount of non-federal
21 money from the State Highway Fund if it uses all of the money
22 apportioned or exchanged to construct highways to standards of
23 the Federal Aid Secondary System;


24 NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the County
25 of Mariposa does hereby notify the State Highway Engineer that
26 the County of Mariposa claims said apportionment of Federal
27 Aid Secondary money and State Highway Fund money for matching

1 and agrees to provide any County money as may be required to
2 complete the financing of projects selected by the County; and

3 BE IT FURTHER RESOLVED that the County of Mariposa desires
4 to exchange its entire apportionment of Federal Aid Secondary
5 money for an equal amount of non-federal money from the State
6 Highway Fund with the proviso that said non-federal "exchange
7 money" and the above apportionment of State Highway Fund money
8 for matching will be used to construct highways to the standards
9 of the Federal Aid Secondary System.
