RESOLUTION NO. 74-58

BE IT RESOLVED that Resolutions No. 70-60, 71-73, 72-1, 72-5, 72-26, 72-63, 73-2, 73-56, 73-66 are hereby repealed.

IT BE FURTHER RESOLVED that employees, except persons under contract or serving by special agreement, elective and appointive officials listed in Mariposa County Ordinance No. 367, and Road Department employees compensated at an hourly rate, shall be paid monthly according to the following 8-step salary range classification plan, with each employee entering employment at the first step of the salary range classification provided for his or her employment or such step thereof as the Board of Supervisors shall by minute order designate at or after the time of hiring, to wit:
