

AGREEMENT NO. EEA 02-214

GRANT NO. EEA 062-0059

MODIFICATION NO. 10

REGISTRATION NO. 72006663

This modification to Agreement No. EEA 02-214 under the
Emergency Employment Act of 1971, hereinafter "the agreement", is entered
into this 20th day of June, 1974 by and between
the State of California, Employment Development Department, hereinafter
"Program Agent" and Mariposa County,
hereinafter "Subagent".

WHEREAS, Program Agent and Subagent entered into the agreement on
September 28, 1971, and

WHEREAS, the U.S. Department of Labor has authorized an extension of the Public
Employment Program (PEP); and

WHEREAS, Program Agent and Subagent mutually desire to modify the agreement,

NOW, THEREFORE, IT IS AGREED THAT:

1. The name of the Program Agent, Department of Human Resources Development
is changed to read Employment Development Department.

2. The termination date of the agreement is extended from June 30, 1974
to March 31, 1975 unless sooner terminated pursuant to direction
by the Department of Labor.

3. The total amount of this contract shall not exceed \$ 137,474

which is an increase in the maximum obligation of the Program Agent from
\$ 106,689 to \$ 137,474. This increase is subject to
the appropriation and availability of Federal funds and the State shall
incur no liability under this amendment unless such funds are appropriated
and available for the performance of the agreement as amended herein.

4. Expenditures by Subagent shall be in accordance with the attached Budget Estimate Revision No. 10. Budget Estimate Revision No. 10 (MA6-50), Enclosure #1, shall supersede Budget Estimate Revision No. 9. The Contractor shall not be paid in excess of actual costs incurred, which in no event shall exceed the total dollar amount of the contract.

5. The Subagent agrees to comply with the guidelines and instructions contained in the "Supplemental Guidelines for the Completion of the Public Employment Program", dated June 1974, Enclosure 2. In the event there is any conflict between the Supplemental Guidelines dated June 1974 and any other guidelines applicable to this Agreement, the Supplemental Guidelines dated June 1974 shall take precedence.

6. All Enclosures referred to in this agreement are incorporated by reference and made a part of this agreement.

7. Except as hereby modified, all terms and conditions of the agreement, as amended, shall remain the same.
