

1 BOARD OF SUPERVISORS - COUNTY OF MARIPOSA

2 RESOLUTION NO. 68-63

3 WHEREAS, parades and community gatherings are held in
4 the Town of Mariposa on various days and hours and said parades
5 and community gatherings require the use of State Highways #140
6 and #49 from the Mariposa County Fairgrounds to the Cemetery
7 Road, or a portion thereof where said highways traverse the Town
8 of Mariposa and/or the streets of the Town of Mariposa, and

9 WHEREAS vehicular and other traffic may be diverted so as
10 not to interfere with said parades and community gatherings in
11 the Town of Mariposa and without inconvenience to the traveling
12 public and the persons using said highway and streets,

13 NOW, THEREFORE, BE IT RESOLVED that the Board of Super-
14 visors of the County of Mariposa hereby directs the County Clerk
15 to prepare application forms for the use of town streets, in-
16 cluding the State Highway traversing said Town, for parades and
17 community gatherings by any person, persons, firms or other
18 organizations.

19 BE IT FURTHER RESOLVED that no parade or community
20 gathering using any portion of the State Highway or city streets
21 within the Town of Mariposa be conducted or held until an
22 application has been made to the Board of Supervisors of the
23 County of Mariposa for a permit to hold said parade or community
24 gathering and said application has been approved by the Board of
25 Supervisors of the County of Mariposa.

26 BE IT FURTHER RESOLVED that in the event any portion of
27 the State Highway traversing the Town of Mariposa is the subject
28 of an application for a parade route or community gathering and
29 the application is approved by the Board of Supervisors of the
30 County of Mariposa, the County Clerk will submit a written request
31 to the State Department of Public Works of the Division of High-
32 ways requesting permission for the use of the designated portion

1 of the State Highway for said parade or community gathering.

2 BE IT FURTHER RESOLVED that the application and request
3 directed to the State Department of Public Works of the Division
4 of Highways designate the day, time of commencement and time of
5 completion, and the route of parade and the area in which a
6 community gathering is to be held and the designated diversion
7 or detour route for traffic during the period of time said State
8 Highway or city street is being used for the purpose of the
9 application.


10 BE IT FURTHER RESOLVED that the Mariposa County Sheriff
11 coordinate with the California Highway Patrol for the necessary
12 traffic direction in accordance with the terms of the permit
13 and approved application, erect such signs, barricades, and
14 other traffic control devices as may be necessary and required
15 to carry out the purposes of this Resolution.
