California Government Code §25020 states:

The members of the board of supervisors shall elect a chairman, who shall preside at all meetings of the board. If he is absent or unable to act, the members present shall select one of their number to act as chairman temporarily by an order entered on the records of the board.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Every year, the Board selects a member to act as Chair for the upcoming year. Kevin Cann was Chair in 2020, Miles Menetrey was Chair in 2019, Rosemarie Smallcombe was Chair in 2018, and Marshall Long was Chair in 2017.

If the Board does not select a Chair for the year, a temporary one will need to be selected each time one is needed.

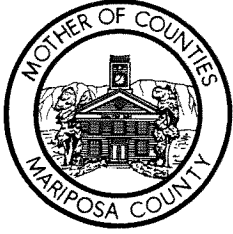
